Message from the District Governor

My Dear 101 Serving Club Presidents and Fellow Rotarians,

We are now in the second month of our year of service. Time is going so fast that before we may even realize it, only 10

months will be left for us to accomplish all our plans and programs for this year. Although we are pressed for time, we must set aside this moment to remember that August is Membership Development Extension and month. We must never forget that the most important element in Rotary is members. Without members, there is no Rotary.

There is a growing concern

among many of our leaders about Rotary's growth because of the alarming decrease in the number of Rotarians worldwide. In the past two years immediately preceding our centennial year, Rotary grew smaller by 22,488 members. Statistics have it, that although 805 new clubs were organized during RY 2002-2003, bringing in a total of 20,736 charter members, membership in existing clubs decreased by 36,000 Rotarians, resulting in a net loss of 15,264 members. During RY 2003-2004, 674 new clubs with a total of 17,276 charter members, were organized. In that year, membership in existing clubs decreased by 24,500, which resulted in a net loss of 7,224 Rotarians.

Past Rotary International President Glen W. Kinross, in his speech before the District Governors-Elect in the February 2005 International Assembly in Anaheim, said: "Fellow Rotarians, it seems incongruous that at a time when Rotary is

> being called upon to meet a broad range of diverse needs, we do so in the face of decreasing membership. There are more Rotarians leaving us than joining Speaking us. bluntly, achieving reasonable а growth annual will remain а dream on the distant horizon until we devise a plan and а method that will ensure a much higher rate of retention. That is a top priority.

The question is: Why do so many choose to leave Rotary? We have

the official reasons given by Rotarians as to why they leave. Out of every 100 men and women who leave Rotary, 13 do so through death. Consider the other reasons. Six claim to leave for health reasons, 12 by loss of classification, 30 cease to live or work in their club's territorial limits, 17 from non-attendance, and 22 quit for other reasons. Frequently cited under "other Reasons" are weak leadership, poorly planned meetings, lack of service activities, failure to challenge members to service, and high average age of other club members. Many of these reasons suggest dissatisfaction with the programs and projects of their Rotary club."

Governor's Monthly Letter

President's Message

Carl-Wilhelm Stenhammar 2005-06 Rotary International President

Dear fellow Rotarians,

August is the Rotary month of membership and extension, an area of great importance to our organization.

The United States leads

the way in total number of Rotarians, with 388,170 members. The second largest country is Japan with approximately 103,700 members, followed by India with about 90,000 Rotarians. A couple of interesting observations are that these three countries alone account for 50 percent of the Rotary population and they are all around the Pacific, where 60 percent of the world population is located.

As to the percentage of a country's population who are Rotarians, the picture is quite different. Iceland is the number-one country, followed by Sweden, Norway, New Zealand, Finland, Denmark, and Australia. It's fascinating to note that all seven top nations come from the Nordic part of Europe and Down Under.

More interesting, however, is the general trend of Rotary membership worldwide. The Far East has a general upward trend. Africa has a trend of small gains like Europe, a steady but small annual positive development. All other areas, unfortunately, show another picture – a downward one.

In the past, we have had several years dedicated to a special and intensive focus on membership. These have been very successful during the time they were implemented, but due to the lack of continuity, the gains have often been lost during the following year.

I think it is wise to work towards goals. However, goals must be easy to understand and reachable. For 2005-06, I have set a goal of a net increase of one member per club. I believe this goal is reachable and understandable. Unfortunately, we have a loss of members each year in the area of 10 percent. This may make the goal more difficult to reach, which is why retention is so critical. If the drop-off rate can be reduced, the goal will be much easier to achieve.

It is therefore of greatest importance that we

a) make our clubs interesting through dynamic programs and meaningful projects,

b) take care of club members so they feel that their membership is relevant to both them and their clubs, and

c) put an emphasis on fellowship and friendship, two of the cornerstones on which Rotary was built.

We need to be strong in membership so that through Service Above Self we can continue to show the world the great leadership of Rotary International.

Group Study Exchange Application Process for Team Members

All interested applicants must first have their candidacy endorsed by a Rotary club in the district where the applicant works or lives. From there, endorsed applications are sent on for consideration at the district level. Club and district deadlines for applications vary, often six months before travel. Applications sent to the Foundation without club and district endorsement will be returned.

Eligibility Criteria

Team members must:

- be between the ages of 25-40;
- be employed full-time in a recognized profession;
- not be a Rotarian, honorary Rotarian, or employee of Rotary or the lineal descendant or spouse of a lineal descendant, a Rotarian, an honorary Rotarian, or an employee of Rotary;

ANNOUNCEMENT FOR SUGGESTIONS TO THE DISTRICT NOMINATING COMMITTEE FOR CANDIDATES FOR THE OFFICE OF GOVERNOR OF R.I. DISTRICT 3850 IN RY 2008-2009

Rotary Clubs of R. I. District 3850 are invited to submit their suggestions for nomination for District Governor in RY 2008-09 for consideration by the District Nominating Committee. In order to receive such consideration, the suggestions must reach the District Nominating Committee through the Office of the District Governor on or before Jan. 7, 2006.

All suggestions shall be submitted in the form of a resolution adopted at a regular meeting of the Club naming the suggested candidate and properly certified by the Cub Secretary, with at least ten (10) copies of the candidate's Bio-Data, following the format of our Districts criteria for the selection of District Governor-Nominee, enclosed. In the event that any Club desiring to suggest a candidate for District Governor-Nominee who is not a member of such Club, concurrence of the Club of which the candidate is a member shall first be obtained.

Clubs desiring to suggest candidates for nomination for District Governor should refer to the R.I. Bylaws [Article XIII, Section 13.020] and pertinent sections of the 2004 Manual of Procedure for the qualifications of a District Governor Nominee and must strictly comply with the Guidelines for Candidates for Elective Positions in RI.

The District Nominating Committee shall convene on January 14, in Iloilo to make its selection. The Nominating Committee shall not limit the selection to those names submitted by Clubs in the District but shall nominate the best qualified Rotarian available to perform the functions of the office of District Governor, properly informing the District Governor of the candidate selected upon making its selection.

Qualifications of a Governor-Nominee

At the time of selection, a governornominee must

1) Be a member in good standing of a club in the district (RIB 15.070.1.)

2) Have full qualifications for such membership in the strict application of the provisions therefore, and the integrity of the Rotarian's classification must be without question (RIB 15.070.2.)

3) Be a member in a functioning club in good standing that has no outstanding indebtedness to RI or to the district as of the close of the Rotary year preceding that in which the Rotarian is proposed as a candidate for nomination for governor (RIB 15.070.3.)

4) Have served as president of a club for a full term or be a charter president of a club having served the full term from the date of the charter to 30 June, provided that this period is for at least six months (RIB 15.070.4.)

Guidelines Regarding Campaigning, Canvassing and Electioneering

Rotary Code of Policies 135, June 2005

It is a fundamental principle in Rotary that the best qualified candidate should be selected for service in Rotary's elective offices. Therefore, any effort to influence the selection process by campaigning, canvassing, electioneering or otherwise is prohibited under the RI Bylaws. The following guidelines shall be followed concerning campaigning, canvassing and electioneering for any Rotarian considering election to the office of president, director, Governor, or representative to the Council on Legislation, or the nominating

Obviously, we have no control over the first four reasons why Rotarians leave us. But we certainly can do something about the 17% who are dropped for non-attendance and the 22% who leave because they are dissatisfied with the plans and programs of their club. Let us stop the hemorrhaging attributed to these two reasons which cause а considerable drain on Rotary's membership. My dear club

presidents, the power to do this is in your hands. With a little more push and careful planning, you can plug the holes that suck away the very lifeblood of this great organization – its members.

By the declaration of our Rotary International President Carl-Wilhelm Stenhammar that his membership goal is a net growth of at least one new Rotarian per club, we can sense that he is sending us three messages. First, is that the goal is very realistic and achievable by all

clubs. Yes, it looks easy enough to accomplish. But when we realize that he is talking about NET growth, the whole picture changes because then we know that he has a second message, which is his emphasis on retention. Recruiting one member is the easy part. Keeping the members that we already have, is the hard part. Again, as R.I. Past President Glen Kinross said, "It is clearly evident that we cannot talk about membership development or recruitment without talking about membership retention."

The third message that I think President Carl-Wilhelm wants to get across, is that while he wants Rotary to have a significant membership growth, he does not want us to embark on a massive membership recruitment campaign which will only result in "mass produced Rotarians," who do not stay very long with our organization. I think he wants us to pick our target recruits well. He wants us to recruit members the old fashioned Rotary way, following





all the steps on "How to Propose a New Member," so that after he is accepted into membership, the new member will be molded into a full blown Rotarian through assimilation and mentoring, while being fed with a constant stream of Rotary information. After doing all these, let us then make sure that his commitment to the ideals and object of Rotary will be deeply rooted. Above all, let us teach him that SERVICE ABOVE SELF, our motto and our theme for this year, is not just a phrase which is to be read, memorized and even understood. Rather, that it is the guiding principle that every Rotarian strives to live by.

committee for any such office. These guidelines are designed to ensure that the best qualified candidate is selected for office:

- Rotarians should at all times conform to the prohibitions of the RI Bylaws concerning campaigning, canvassing or electioneering. All Rotarians should observe both the letter and the spirit of the bylaws and refrain from any activity whose purpose or effect is to influence others by promoting or soliciting support for a candidate's or another Rotarian's candidacy. Such activity is repugnant to the spirit of the bylaws and the principles of Rotary and will be grounds for disqualification of a candidate.
- Campaigning, canvassing or electioneering is any action seeking votes, requesting support in a forthcoming election, distribution of literature or promotional materials or other overt actions intended to promote one's candidacy for an elected Rotary office.
- 3) The periods of candidacy for elective office begin when individual Rotarians begin to give serious consideration to submitting their names for a position covered by the RI rules for nominations and elections. Commencing at that time, candidates should be particularly careful to avoid any actions designed to publicize their names or achievements, to call attention to the applicable nominations or elections, or to give candidates an unfair advantage over other candidates for the same position.
- The normal performance of duly-assigned Rotary activities would not be considered to be a violation of the policies related to campaigning, canvassing or electioneering.
- Should a candidate become aware of any campaigning or electioneering activities which are undertaken on the candidate's behalf, the candidate shall immediately and in writing express disapproval to all concerned and instruct them to terminate such activity. (Jun. 2001 Mtg., Bd. Dec. 325)

5) Demonstrate willingness, commitment, and ability, physically and otherwise, to fulfill the duties and responsibilities of the office of governor as provided in RI bylaws section 15.090. (RIB 15.070.5.)

6) Demonstrate knowledge of the qualifications, duties, and responsibilities of governor as prescribed in the RI bylaws and submit to RI, through its general secretary, a signed statement that the Rotarian understands clearly such qualifications, duties, and responsibilities. Such statement shall also confirm that the Rotarian is qualified for the office of governor and willing and able to assume the duties and responsibilities of the office and to perform them faithfully. (RIB 15.070.6.)

Additional Qualifications

In addition to the qualifications of governornominee, a governor, at the time of taking office, must have completed seven years of membership in one or more clubs and have attended the governors-elect training seminar and International Assembly. (RIB 15.080.) Governors also should

1) Possess the esteem and confidence of their own clubs

2) Be of high business or professional standing, with executive ability, demonstrated in the conduct of their businesses or professions

3) Have their business or professional work so well organized that they can give the time necessary to carry out Rotary work

4) Be persons whose integrity and the conduct of their immediate families is above reproach

5) Have a thorough knowledge of Rotary, its purposes, Object, and constitutional documents, and be Rotarians of recognized loyalty to RI

6) Be able to discuss any phase of Rotary in a convincing manner and convey information articulately

DISTRICT SECRETARY'S CORNER

Let's face it, the first month of Rotary year 2005-2006 is a month where most club officers still familiarize themselves with club administration. Some clubs are more prepared than others where club activities are already planned. Others are late starters while others up to this point still have not set any directions for their club. Clubs, which have not yet prepared their plans and programs for this Rotary year, must by this time already plan their activities for the year. I suggest that each club must aim for a goal or goals – a Presidential Citation or a District Award, a community recognition, anything that would motivate everyone to participate.

If the attendance rating of the fifty one clubs who submitted their monthly attendance rating (MAR) is an indication of how well-prepared a club is, let us look at the ratios below:

Rating	No. of Clubs	Percentage Distribution
90% & above	6	12%
80% to 89.99%	20	38%
70% to 79.99%	11	22%
Below 70%	14	28%
Total	50	100%

Statistics show that only 50% of the clubs who submitted their monthly attendance report have a rating of 80% and above while more than one fourth have ratings below the 70% mark. This is the reason why the district has an average attendance rating of only **77.90%** in July. Still a passing grade but can still be improved. I just hope the members were not burned-out by the barrage of activities during the centennial year.

Noteworthy to mention is the Rotary Club of Midtown Iloilo, which has a perfect attendance for the month of July. The club is worthy of emulation by all the other clubs in the district. If we aim together for an attendance rating of no less than 90%, I am sure we will have a higher average attendance rating for the Rotary Year 2005-2006.

I would like to acknowledge the club secretaries who submitted their MAR early specifically Sec. Jayvee Atilano of RCZC West who was the first to submit followed by Sec. Ogee Almonte of RC Dipolog and Sec. Prime Dizon of RC Boracay. I

hope the others will follow suit without any reminders from my end. The district office has yet to receive copies of the weekly bulletin though from most of the clubs.

Clubs who submit pictures for publication in the GML must have a brief write-up about the activity. It is encouraged that action pictures be submitted rather than posed shots of club members to make it look more meaningful. Pictures say a thousand words. To have better quality pictures, digital shots should at least be 2 megapixels and scanned pictures should have a resolution of at least 200dpi. Also, please send the images as a separate attachment rather than including it in a Word Document


Ideal Candidates

Rotary Club of Zamboanga City North Launches District's Biggest Billboard

In response to Rotary International's Campaign for public awareness, Rotary Club of Zamboanga City North answered the call. Headed by Club President Romeo Camins, RCZC-North wanted to focus on membership. With the catch phrase "Let Us Help You Help Others. Come Join Us!", the billboard embodies Rotary's invitation for new members. While



other clubs in the Zone were putting up their billboards, President Romy wanted diversity in the billboards. As Rotary begins it's second century, his goal is to go back to basics and focus on membership extension and retention.

Although RI is encouraging the use of their list of official billboards, the club opted for an original concept featuring one of the indigent beneficiary of the club. The design of the billboard and photo was taken by Rotarian Kerwin Baldovino. It measures 24ft in width and 12ft in height. Tarpaulin printing in Zamboanga is 60php per sq. foot. It was installed on August 16, 2005. The billboard is supported by steel pipes and hanged at the side of Jardin de La Viña Hotel. The Hotel is located near the corner of the city's main intersection. The billboard is clearly visible by hundreds of commuters and motorists everyday as they pass through that junction.

President Romy is hoping that his club has paved the way for other clubs in the district to follow and make the effort of putting up billboards.

On July 4, 2005, more than a thousand residents of Binuntucan, Pontevedra, Capiz felt blessed when the Rotary Club of Metro Roxas together with the Rotary Club of San Diego, Paradise Valley, California USA visited them on a Global Medical Mission.

A Medical Team from the Rotary Club of San Diego, Paradise Valley, CA, USA headed by their Charter President Romeo V. Villanueva with Incoming Pres. Gabriel Perpetua and Rotary Club of Metro Roxas headed by Pres. Heles "Boy" Tunguia. The Team was composed of doctors, nurses and dentists along with our local Medical practitioners joined forces as they delivered free medical-dental and surgical services to a total of 1,047 patients in Brgy. Binuntucan, Pontevedra, Capiz. Among the services delivered include 115 Dental Extraction, 20 Circumcision, 4 Cyst Removal, 306 Deworming, 437 Consultation and Check-up. 165 patients also received Multi-Vitamins Chewable. Congratulations to DISTRICT 3850 which was the only Philippines district with no terminated clubs. A fantastic effort from District 3850 & a special thank you to the Past DG & his team.

A few districts had just one club terminated so congratulations to D3800 & D3790. I know the D3800 Club is working hard to get their club reinstated having had much contact with RI offices recently, concerning this matter.

How to get the Club Reinstated (if terminated) Clubs need to pay outstanding dues PLUS the \$10 per member for Reinstatement fee, and supply the 2 most recent SAR membership lists. Realistically, the clubs need to sort the matters by mid September 2005, so that Phil Consulting & RISPPO can report to WHQ.

If not settled by this time, the clubs will have additional requirements being:

- Pay additional \$15 USD per member Charter Fee (in addition to the \$10 per member they already owe for Reinstatement fee)
- Complete Reinstatement Application
- Supply Members List & details of members (application form)
- Supply the last two SAR members list
- Other paperwork.

Your efforts to reduce the number of terminated clubs is greatly appreciated.
